

## **MEMORANDUM OF UNDERSTANDING**

**Between**

**UNIVERSITY OF MALAYA, MALAYSIA**

**And**

**LAMBUNG MANGKURAT UNIVERSITY (ULM), INDONESIA**

University of Malaya as represented by its Faculty of Engineering and Lambung Mangkurat University hereby agree to promote academic and educational collaboration and exchange between the two institutions, with the joint purposes of improving mutual understanding between the two institutions and contributing to advancement of activities in the areas of mutual academic and educational interest.

### **Contents of the Collaboration Program:**

1. The University of Malaya and ULM Indonesia agree to implement within the framework of the rules and regulations applicable in each of the institutions and subject to availability of funds and resources, the following programmes and activities, which may include, but not limited to:
  - i) exchange of visiting faculty and research staff;
  - ii) exchange of students;
  - iii) joint research on scientific and technological subjects;
  - iv) joint scientific and technological meetings, symposiums and lectures;
  - v) exchange of academic findings, publications, and academic and educational information;
  - vi) other academic and educational collaboration and exchange approved as suitable by the two institutions.

### **Implementation of the Collaboration Program:**

1. The activities listed above are to be carried out after mutual consultation and approval of the two institutions and the divisions concerned. It is also agreed that the


terms and financial arrangements in respect of the implementation of any or all of the above activities shall be negotiated separately

**Term of Memorandum of Understanding:**

1. The institutions acknowledge that all visits or exchange of staff or students will be subjected to compliance with entry and visa regulations of Malaysia and Indonesia and with the institutions requirements in respect of staff or student visits.
2. The Parties agree to designate, on behalf of each institution, a coordinator whose responsibility will be to supervise the execution of this MOU and to draw up a programmes or activities to be implemented under this MOU. For this purpose, the coordinator for University of Malaya is **Assoc. Prof. Dr. Andri Andriyana** and for ULM Indonesia is **Dr. Muthia Elma**.
3. This Memorandum of Understanding shall become effective when the representatives of the University of Malaya and ULM Indonesia put their signatures below, and shall remain effective for three (3) years. The two institutions must consult each other if one or both of the institutions desire to renew the Memorandum of Understanding at the end of the three years.
4. The two institutions must consult each other when they wish to revise or terminate the Memorandum of Understanding before the end of effective term. Notwithstanding anything contain in this clause, this MOU may be terminated by either Party giving written notice to the other at least six (6) months prior to the proposed date of termination.
5. This MOU may be modified, varied or amended at any time after due to consultation and with the written agreement of both Parties.
6. This Memorandum of Understanding is only intended to be a statement of understanding and cooperation between both institutions and is not intended to be legally binding.
7. Any difference or dispute between the Parties concerning the interpretation and/or implementation and/or application of any of the provisions of this Memorandum of Understanding shall be settled amicably through mutual consultation and/or negotiations between the Parties through diplomatic channels, without reference to any third party or international tribunal.
8. Each Party reserves the right for reasons of national security, national interest, public order or public health to suspend temporarily, either in whole or in part, the implementation of this Memorandum of Agreement which suspension shall take effect immediately after notification has been given to the other Party through diplomatic channels.




